		teachers. The Conference calls on the Welsh Government and the Local Authorities to
		provide adequate funding in order to abolish this practice.

		avoids publicity

	Wording:	The Conference calls on UCAC to condemn Local Authorities and school leaders who
		consider that it is acceptable to necessitate the cutting of full time jobs to part time jobs.

	Wording:	It is unacceptable to expect anyone to fulfil Head of Department responsibilities without remuneration. This Conference believes that appropriate and fair remuneration is required in each case, and we call on school governors and headteachers to ensure that appropriate and fair remuneration is provided.

	Title:	The creation of a system to support schools with regard to Health and Safety issues	
	Wording:	The Conference calls on Local Authorities to create a system to support schools with	
		regard to Health and Safety issues, which would be delivered as part of a Service Level	
		Agreement. This would enable schools to receive specialist advice and support in order to	
		fulfil statutory duties and safeguard pupils, workers and school visitors. It would also allow	
		school leaders to concentrate on their main responsibility, which is to lead teaching at the	
		school and raise standards.

	Title:	Guidelines on administering medicine to pupils
	Wording:	We need to recognise that an increasing number of pupils (of all ages) have complex or
		challenging personal and medical needs. The Conference calls on the Welsh Government

		Medical Needs' guidance in order to improve clarity and ensure appropriate care for
		pupils whilst safeguarding members of staff. Appropriate indemnity, relevant training and
		recognition in terms of time and pay should be ensured where appropriate.

		and remove the loophole which means that teachers and lecturers wishing to contribute
		to the Teachers' Pension Scheme are prevented from doing so.
